

# Manchester Billiards

## Warranty

Manchester Billiards Table is warranted to be free from all defects in material and workmanship. The warranty is granted only to the original purchaser. To make a claim you must present proof of purchase. For warranty registration, complete our Warranty Reply Card. Excluded are any products sold or used for commercial use. The 3 year warranty is subject to the following limitations and exclusions:

### Limitations & Exclusions

#### ***Improper Care***

Please take care to treat your Manchester Billiards Table like the fine product it is. Proper care and use are essential to preserving this warranty. Manchester Billiards will not repair or replace parts if improper maintenance or improper use causes damage. This warranty does not apply if your Manchester Billiards Table is damaged by the use of detergents, abrasives, or other harsh cleaning agents.

#### ***Accidents, Abuse, or Normal Wear and Tear***

The warranties do not apply in case of defects judged by Manchester Billiards to have occurred as a result of normal wear and tear, accidental damage, fire, flood, storm, earthquake or other catastrophe, alteration, misuse, abuse or neglect of the parts affected, or to billiard tables used in an institutional or commercial location.

#### ***Billiard Cloth and Other Items***

This warranty does not cover billiard cloth (installation or reinstallation), cushions, table pockets, playing accessories or table leveling.

In the event of a defect in materials or workmanship, notification of the defect should be made through an authorized dealer whom the product was purchased. All warranty claims must be made through Manchester Billiards or its Authorized Dealers or Agents. If, after inspection, the parts are determined to be defective, they will be repaired or replaced and returned prepaid by conventional surface freight. Any costs or charges required to disassemble, prepare for return and reassemble will be the sole responsibility of the owner. Replacement or repair of defective parts shall constitute complete fulfillment of all obligations with respect to the product. Shipping costs are the responsibility of the owner for any claims made more than one year from the date of original purchase. The warranty does not require the replacement of the entire table. As a matter of warranty policy, Manchester Billiards will not refund the consumers purchase price.

Manchester Billiards guarantees 1" slate to be manufactured utilizing the highest standards of workmanship. The slate is guaranteed for so long as the original purchaser owns the table.

If the billiard table is installed by anyone other than an authorized Manchester Billiards dealer or service agent, the obligation hereunder is voided.

This warranty is not transferable by the original owner. The foregoing warranty is in lieu of all other warranties, express or limited. Manchester Billiards neither assumes nor authorizes any person to assume from Manchester Billiards any other obligation or liability in connection with said billiard table. This Warranty gives you specific legal rights. In addition, you may have other legal rights, which may vary from state to state.

#### **Limitation**

The time limitations and terms of the above warranty, the same will only be applicable if the warranty Reply Card is returned within 30 (thirty) days of the purchase.
